Code of Conduct for Students

All the students of The Charutar Vidya Mandal (CVM) University shall adhere to the **Code of Conduct** as given below:

- (1) Students are required to behave in a disciplined and dignified manner with fellow-students, staff, teachers and visitors etc. within the University/College campus and hostels.
- (2) Students should not involve in any act of discrimination of any type irrespective of gender, caste, creed, race, religion, ethnicity, nationality, socioeconomic status, disability or language etc.
- (3) Students are required to attend all the theory/practical/tutorial classes and maintain his/her attendance as per minimum eligible criteria which is **75%** in each of the course or as per UGC guidelines issued time to time to appear for External Theory / Practical Examination in respective course (subject) in each term (Semester/Trimester/Professional). The 25% absence shall include leaves for all co-curricular & extracurricular activities, medical and personal leaves etc.
- (4) If attendance of any student in '**Theory lecture**' in any course **falls less than** minimum eligible criteria, **the university/college shall detain the student from appearing in the** External Theory and / or Practical Examination of that particular subject / course.
- (5) If attendance of any student in '**Practical or tutorial classes**' in any course **falls less than** minimum eligible criteria, the student will not **be allowed to submit practical file / term-work for that particular subject/course**. Student will be considered as "**Term work not submitted**" and practical term shall not be granted.
- (6) Use of cell Phone within the campus is strictly prohibited. Use of University's digital platform, personal mobile phones, camera, smart watch or tablet etc. for illegal/ un-authorized/ AI generated photography, videography, recording, cyberbullying, hacking within the campus and hostel is strictly prohibited. If student is found using such devices in the locations as stated above, a strict disciplinary action (such as forfeiting of the device(s) or imposing fines) shall be taken. Students are not allowed to upload any illegal / unauthorized / unethical / AI generated contents on any kind of internet platform/social media which tarnish the image of any person or college or university.
- (7) Students are not allowed to cause or involve in any sort of violence or disturbance or indulge in any damage to the University / College properties within the campus.
- (8) Students are not allowed to consume / possess / sell / buy any drugs, alcohol, tobacco etc. which are prohibited by the laws of government and/or for which any statutory warning for non-consumption is issued.
- (9) Students are required to pay the 'Full Term Fee', in accordance with 'Fee circular' or fifteen days before the date of commencement of new term.
- (10) Ragging is strictly prohibited. Students involved in ragging may face strict disciplinary actions.
- (11) Students are expected to dress in decent attire and wear their I-card within the college premises.
